



WEBSITE SUBSCRIPTION SERVICE AGREEMENT

This Website Subscription Service Agreement (“Agreement”) is entered into between **Hashtag Media** (“Provider”) and the Client (“Client”) as of the date of acceptance.

1. SERVICES PROVIDED

Hashtag Media agrees to design, develop, host, and maintain a website for the Client under a subscription-based model. Services include:

- Website design and development based on selected package
 - Hosting and security (SSL included)
 - Ongoing maintenance and fixes
 - Up to **30 minutes of revisions per month**
 - SEO setup based on selected plan
 - Google Analytics setup (if applicable)

2. SUBSCRIPTION MODEL

This service is offered as a **monthly subscription**, allowing the Client to access a professionally built website without a large upfront investment.

- Monthly fees are billed in advance
 - Subscription must remain active for the website to remain live
 - Services continue as long as the subscription is active

3. WEBSITE OWNERSHIP

The website remains the property of Hashtag Media under the subscription model.

- The Client does **not own the website** during the subscription period
- The website may not be transferred, copied, or hosted elsewhere
- Access to source code or backend systems is not provided

4. OWNERSHIP OPTION

After **24 months of continuous service**, the Client may:

- Take full ownership of their current website, OR
- Continue with a full rebuild, which begins a new 24-month cycle

Ownership applies only to the current version of the website and does not include future redesigns or rebuilds.

5. REVISIONS & SUPPORT

Each subscription includes:

- Up to **30 minutes of revisions per month**
- Minor updates such as text changes, images, and small adjustments

Additional work beyond 30 minutes is billed at a discounted hourly rate.
Unused time does not roll over.

6. REBUILDS

After 24 months, Clients may request a rebuild at a discounted rate.

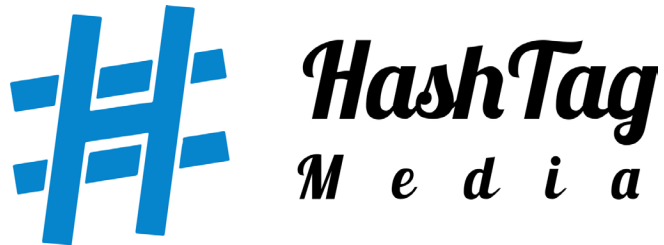
- Rebuilds include updated design and structure
 - Rebuilds restart the subscription cycle

7. CLIENT RESPONSIBILITIES

The Client agrees to:

- Provide accurate and timely content
 - Ensure all provided materials are legally owned or authorized for use
 - Communicate approvals and feedback promptly

8. THIRD-PARTY SERVICES



Some features may require third-party services (e.g., domains, Shopify, integrations).

- These are billed separately to the Client
 - Hashtag Media is not responsible for third-party service disruptions

9. CANCELLATION

- No long-term contract is required
 - Client may cancel with **30-day written notice**
 - Upon cancellation:
 - Website is removed from hosting
 - No ownership is transferred unless buyout is completed

Hashtag Media will not be held liable for:

- Loss of revenue, business, or data
 - Third-party service issues
 - Unauthorized use or modification by the Client
